- 1 - Excludes amounts related to Employment Benefits and Support Measures, delivered under Part II of the Employment Insurance Act.
- 2 - For any data before January 1997 or for any amounts related to Employment Benefits and Support Measures before January 2011, refer to archived tables 14-10-0170-01 and 14-10-0179-01.
- 3 - Administrative data on Employment Insurance special benefits for self-employed workers are only available at the regional data centre level. For this reason, Atlantic provinces are rolled up and included in the Prince Edward Island statistics, while the western provinces and the territories are rolled up and included in the Alberta statistics.
- 4 - Due to the COVID-19 situation, many Canadians who were not employed and seeking income assistance between March 15 and September 26, 2020, were accessing Government of Canada benefit programs other than Employment Insurance, such as the Canada Emergency Response Benefit (CERB). As a result, the Employment Insurance Statistics program was suspended between the March and September 2020 reference months.
- 5 - Benefit characteristics are either benefit payments representing the total Employment Insurance (EI) disbursements to all beneficiaries including retroactive adjustments, or benefit weeks representing the total number of weeks for which benefit payments have been made to all beneficiaries, during the reference month.
- 6 - Includes benefits paid to people receiving regular income benefits whether or not they participate in one of three employment benefit programs, namely Skills Development Program, Job Creation Partnerships Program and Self-employment Program.
